CONSENT AND RELEASE FORM

I am the parent or legal guardian of _____ and I agree to the following terms to permit my child to participate in the Long Island Children's Choir (LICC).

1. Code of Conduct, charges, attendance, uniforms: I have read, understand, and agree to comply with the Student Handbook of the Long Island Children's Choir (LICC), including the rules concerning child conduct at all rehearsals and events. I understand that my child may be, in the discretion of the Director, suspended from or asked to leave the LICC in the event my child violates any portion of the handbook. I agree to pay the semester tuition, music fees, uniforms, and concert fees as outlined in the LICC handbook, and that concert uniforms may not be worn outside of an LICC performance without specific approval of the Director. My child will attend all practices and I will provide notice to the Director whenever my child needs to be absent from or late to rehearsals and/or performances because of illness or other circumstances. I understand that my child may not be able to perform at the LICC's next scheduled event or my child may be asked to leave the LICC in the event of inadequate attendance at rehearsals.
2. Ownership of recordings: The LICC is the sole and exclusive owner of all intellectual capital produced by the choir, including but not limited to, any professional recordings made of concerts, photographs of the LICC used for promotional, recruitment, or other purposes.
3. Consent to photograph: I give the LICC permission to publish, without charge, photographs taken while my child is participating in the LICC activities including, but not limited to, rehearsals, concerts, or when traveling as part of the LICC. These photographs may be used in publications, including electronic media, or in audiovisual presentations, promotional literature, advertising, or social media. On occasion, local news organizations may hear of our activities or events or the LICC may invite or allow them to photograph or record our events. I consent to the use of any such audio or visual record of my child to be used by the news media and for my child to be interviewed by the news media.
4. Limited supervision and waiver: I understand that the LICC takes reasonable steps to provide adequate supervision and care of my child at rehearsals, performances and other events. However, I assume full responsibility for my child's welfare and safety, including all responsibility for transporting my child to and from rehearsals and events. I release the LICC, its Director, staff, Board of Directors, agents and subcontractors from any liability that may be incurred in connection with my child's participation in the LICC.

5. Consent to be included in directory: The LICC may make a directory available to all families of LICC participants in order to facilitate communications about LICC-related matters. I agree to allow my child's name and contact information to be included in the directory.

6. Medical emergency and waiver: In the event a medical emergency arises and the LICC cannot reach a parent or emergency contact, I authorize the LICC to seek treatment for my child at the nearest medical facility. I further authorize my child to receive such treatment as is deemed necessary by the attending physician, including sutures, anesthesia, and surgery. I consent to pay all costs for such treatment. I understand that the LICC would not allow my child to participate in the LICC without releasing and holding harmless the LICC. In consideration, I agree to release and forever discharge the LICC, its officers and directors, and its employees, their agents, and parties volunteering on behalf of the LICC from all actions, causes of actions and claims of damages of any kind growing out of or that relate to any activity of the LICC. This is a full and complete release for all injuries and damages that my child may sustain as a result of participation in any LICC activity.
